Teresa Johnson, Chairperson called the meeting to order at 11:45am

Teresa Johnson (TJ) presented a proposal that she remain in the position of District Chair and Janice Smith be elected as Vice Chair. This will allow Janice to attend the BOG meetings to represent District 3 if TJ is not available to attend the meeting. The members were accepting to the proposed change, and it was presented as a formal vote and passed unanimously.

The bonding of the District officers was discussed and the District 3 will continue/renew the certificate to be bonded through the company they the District is presently bonded through and will submit the certificate to the Central Office (Brenda Williams-Brown)

Janice presented an update on the Central Office in regards to a need for a new phone system so staff can access/answer telephone calls w/computer access, sewer gas problems in the men's bathroom and a snake visitor...which identified 3 points of entry that will need to be repaired.
