How Can I Enroll In the Plan?

Complete the attached enrollment form and send it to the Member Benefits Department. Your cost for the plan will then be automatically deducted from your pay or pension. Once you enroll, you must remain in the Plan for 12 consecutive months. Your enrollment will continue thereafter, unless you opt out or you terminate your SEANC membership. Non-Covered Items

What Are the Exclusions? Excluded services are those legal services that are not provided under the plan. Please see your plan description for complete details and exclusions. Excluded services include the following: (1) employment-related matters, including state, Association and statutory benefits; (2) matters involving the employer, SEANC, MetLife® and affiliates, and plan attorneys; (3) matters in which there is a conflict of interest between the Plan Member and spouse or dependents, in which case services are excluded for the spouse and dependents; (4) appeals and class actions; (5) farm and business matters, including rental issues when the participant is the landlord; (6) patent, trademark and copyright matters; (7) costs or fines; (8) frivolous or unethical matters; and (9) matters for which an attorney-client relationship exists prior to the participant becoming eligible for plan benefits.

*You will be responsible to pay the difference, if any, between the plan's payment and the non-plan attorney's charge for services.
