## House Budget Preview RIFs University Personnel

The North Carolina House of Representatives Appropriations Committee held a public hearing on Monday, May 24, for citizens to voice their concerns regarding the state budget. However, SEANC lobbyists noted that 75 percent of legislators were no shows, leaving the distinct impression that this “request for public input” was nothing more than a publicity stunt by the House.

Less than two days later, the House budget subcommittees began offering their versions of next week’s budget. Of extreme concern is that 1,700 UNC system jobs are on the chopping block at management’s discretion in order to save public school jobs. “I got news for you, university jobs are education jobs too,” said SEANC Executive Director Dana Cope. It is unknown at this time exactly how many of the jobs are filled and how many of the position are vacant.

Three State Health Plan (SHP) bills were filed at SEANC’s request this week by Reps. Nelson Dollar (R-Wake), Hugh Blackwell (R-Burke) and Pat Hurley (R-Randolph). HB 1968 would repeal the BMI penalty from the SHP. HJR 1969 would open the secret contract between Blue Cross Blue Shield, and HB 2037 would move the oversight of the SHP from the Legislature to the Department of Insurance.

The House will convene on regular schedule Monday at 7:00 p.m. with a skeleton crew and will not take any votes on legislation. The House intends to roll out its version of the state budget by mid-week and complete their votes with a final budget by Friday, June 4. Anything in the House and Senate budget proposals that differs will then move to a House-Senate Conference Committee to hammer out the details. The House has made no announcements regarding the retirement system contributions.

Now is the time to contact legislators on the budget and the State Health Plan bills to affect some change this year.
